

**CASCADES ACADEMY CAMP CREATE**  
**CONSENT TO PARTICIPATION, CONSENT TO TREAT,  
WAIVER AND RELEASE, AND INDEMNIFICATION**

In consideration of the below-named individual's (the "**Participant**") participation in the camp(s) indicated below and all associated activities (the "**Activities**") during the 2018 Summer Camp Series, the Participant and his/her parents or legal guardians ("Parents"), execute this Consent to Participation, Consent to Treat, Waiver and Release, and Indemnification (this "**Agreement**") for the benefit of Cascades Academy (the "**School**"). The Participant desires to participate in the following camp(s), which may from time to time require the Participant to take school-sponsored transportation off school premises:

Parents further acknowledge the Participant is participating in the Activities based solely upon the undersigned's own judgment as to the Participant's fitness to participate. The Parents represent and warrant that they are not relying on any judgment or representation of the School as to the Participant's fitness or ability to participate. The Parents attest that the Participant is in good health and has no physical condition that would prevent or hinder participation in the Activities.

Further to this point, during the course of each camp listed above, Participants will be swimming at Tumalo State Park or specially noted field trip locations. Swimming will take place at designated area and will be generally supervised by camp staff. Although the designated area is relatively shallow, signage at the area indicates that swimmers all "swim at their own risk." If Participant requires a life jacket, this must be provided by the Participant/Parent and sent with the Participant to camp each day and Parent must check the box immediately below.

I (we) recognize that the Activities are a hazardous and dangerous and that they present inherent risks that can lead to serious injury or death, including, without limitation, bodily injury (including, for example, concussion and injury to the neck, back or spinal cord); weather-related conditions (including, for example, dehydration and sunburn); risks inherent in transportation [including, but not limited to by bus, car or bike]; property loss/damage, defects in product design, manufacture, or construction; slipping and falling; improper lifting or carrying; and medical decisions made by the School on the Participant's behalf pursuant to the authorization below. **Parents voluntarily permit the Participant to be transported by School owned vehicles, chartered vehicles, or other transport.** Parents voluntarily permit the Participant to participate and Participant and Parents expressly assume and accept the risks inherent in the Activities. Parents and Participant accept their responsibility to be informed. Participant agrees to take precautions to self-protect against risks, to behave prudently, to conduct himself/herself in a safe manner, and to read and abide by all reasonably available sources of information about the Activities.

In consideration of the School granting the privilege of participating in the Activities, the undersigned Parents forever release, acquit, and discharge the Released Parties from all present and future liability from any and all claims, demands, or causes of action (including costs and attorneys' fees) that they might assert on their own behalf, including claims arising in whole or in part from the negligence of one or more of the Released Parties or the intentional misconduct or negligent acts or omissions of the Participant, any other participant on the Trip, or any other third-party. The Parents further agree that they will not sue the Released Parties for money damages, personal injury, or property damage sustained by the Participant on the trip, even if due to the negligence of one or more of the Released Parties. However, the Parents do not waive any claims arising from the Released Parties' gross negligence or intentional misconduct.

The Parents further agree to defend, indemnify and hold harmless the Released Parties from any and all claims, lawsuits or demands made by anyone arising from or relating to the Participant's involvement with the Trip, including, but not limited to: (1) claims alleging the negligence of one or more of the Released Parties; (2) claims that may be brought by or on behalf of the Participant (or his or her heirs or assigns), in light of his/her status as a minor; (3) and claims against the Released Parties for harm or damage to persons or property alleged to have been caused by the Participant. However, the Parents are not required to indemnify the Released Parties for any claims alleging the Released Parties' gross negligence or intentional misconduct.

In the event that the Participant requires emergency medical attention or hospitalization in connection with his or her participation in the Activities, I (we) hereby authorize any employee of The School to seek, authorize, and obtain all necessary and appropriate treatment for my child at a hospital, doctor's office, emergency medical service provider, or other medical service provider.
